# 2.BUSINESS/CONFERENCE/EXHIBITION/FAIR/ACTIVITY/SEMINAR/MEETING PURPOSE VISA

### 1. Introduction

Applicants who wish to visit Türkiye for business purpose can apply for visa regarding on passport of his/her nationality. Please check <a href="http://www.mfa.gov.tr/visa-information-for-foreigners.en.mfa">http://www.mfa.gov.tr/visa-information-for-foreigners.en.mfa</a> for visa regulations.

# a) Electronic Visa Application System (E-visa) www.evisa.gov.tr

The person who is eligible for e-visa can obtain his/her 30 days single entry e-visas via the website: <a href="www.evisa.gov.tr">www.evisa.gov.tr</a> without coming to Turkish Consular Offices. If your are not eligible for e-visa, you should apply for sticker visa to Turkish Consulate-General in Guangzhou.

## b) Pre-Application System for Turkish Sticker Visa www.visa.gov.tr

For getting Turkish sticker visa, applicants reside in Guangdong, Fujian, Hainan Provinces or Guangxi Zhuang Autonomous Region) will follow the steps cited below:

- ✓ Log in the website of www.visa.gov.tr
- ✓ Fill in the form (a)Nationality and Visa Detail Information, b)Personal Information, c)Contact Information d)Travel Information)
- ✓ Upload required documents
- ✓ Download and print out the online application form
- ✓ Finally, submit your application and make an appointment

# 2. Required documents

- 1. Biometric Photo (size 50\*60 with clear/white background)
- **2.** Original and copy National passport or official travel document valids for at least 90 days longer than the expiry date of the requested visa /containing at least one empty page

- **3.** For Chinese who are inhabitant/have residence permit in our jurisdiction area as well as Non-Chinese who have valid residence/work permit or Chinese Visa valid for at least 90 days should submit their residence permit card/document.
- **4.** Fulfilled and printed online application form signed by applicant (form should be proceeded online via <a href="https://www.visa.gov.tr">www.visa.gov.tr</a>)
- **5. Proof of travel health insurance,** valid through duration of stay, including;
- a) covering a minimum of 30,000 Euros or equivalent in Yuan
- b) transfer of the insured to the closest medical facility or residence after hospitalization..
- 6. Non-refundable visa fee
- **7. Flight reservation** (It is advisable that the flight ticket is bought after the visa has been granted.)
- **8.** Documents attesting to the identification status of the applicant and inviting person-((notarized/certified) letter of recommendation, (notarial/certified) retirement certificate, work-employment certificate, study certificate,)
- **9.** A notarized/certified invitation letter from invitee organisation/company **or** Invitation letter or document on attending an event
- **10.** Reference/Dispatch letter from Chinese company (it has include your contact information in Türkiye) with Chinese company's business license copy.

(Reference/Dispatch Letter-with certification for Chinese National)

(Reference/Dispatch Letter-without certification for Non-Chinese National)

- 11. Documents attesting to the income status of the applicant (Land registry/ Notarized Work Certificate/ Bank Account Statement) bank account statement showing transactions at least within the past 3 months or a time deposit at a bank for at least 3-months as of the date of application (the amount are supposed to be enough to cover travel costs.
  - ✓ If all costs will be covered by invitee and this is stated in the notarized invitation letter, bank account statement is not required. (Optional)
- **12.** Some additional documents might be requested by applicants in some individual situations cited below: (while interviewing, if our stuff finds it necessary to obtain further information,

there is a possibility that you may be asked to submit some additional documents. Examples of such documents are given below only for information purposes:)

- √ The copy of marriage certificate (for couples travelling together)
- ✓ Copy of birth certificate (for children younger than 18 years old)
- √ (For students travelling alone) proof of solvency of parents
- ✓ If one of parents cannot come to the Consulate for application of children who are under 18 years old, a notarized written consent from that parent, must be submitted upon visa application by the other parent.
- ✓ Original and copy ID card (if any)

#### 3. NON-REFUNDABLE VISA FEE AND VISA ISSUE PERIOD

First step, single-entry visa fee will be charged in cash. After approval, the rest of fee for multiple-entry will be collected in cash.

#### 4. INTERVIEW AND SUBMISSION OF THE ORIGINAL DOCUMENTS

Following the online application, the applicants should apply to the Turkish Consulate-General in Guangzhou in person to complete the procedures including interview and submission of their application form, their passports besides original application documents and /or original copies of the documents on appointment date and time.

### 5. OTHER USEFUL POINTS

- \*Applicants should apply in person. Applicants below the age of 18 should be accompanied with their parents or legal guardians with passports and other required documents.
- \* The applicants who would like to travel their family members will record the necessary data regarding their family members separately.
- \* It is strongly advised for applicants to apply at least one month prior to their intended trip.
- \* Please do not finalize your preparations or travel plans until you are informed about the conclusion of your visa applications or getting your sticker visa.
- \* If you have been to Türkiye before, please submit your previous visas or old residence permits in Türkiye (Optional but advisable to submit)
- \*The process of Turkish visa application of Non-Chinese Nationals who have Chinese visa valid for at least 90 days takes 3-5 weeks.
